Mentorship Event at PCHS: April 17

The Young Professionals Program has a date for our Career Networking event! On April 17, Pocahontas County High students will have the chance to meet with local business owners and learn more about their career options.

Along with the Pocahontas County Prevention Coalition, the Chamber will host the Career Networking Day, during which students and business owners will meet at PCHS to discuss mentorship opportunities. This event can serve as a mock interview, and will enable both the student and business owner to determine if the partnership is a good fit.

The Young Professionals program, which was funded by a grant from the Snowshoe Foundation, aims to assist Pocahontas County High School with its student mentorship program, which is a requirement for graduating seniors. Each student must complete a "72-hour work-based learning experience (mentorship)" in order to graduate; typically, it is performed in the summer before one's senior year. The mentorship must correspond to the student's particular field of study and is intended to help the student make more informed career decisions.

The Chamber will also present sophomores and juniors with an organized, categorized directory listing Chamber businesses that are interested in sponsoring student mentorships. Each listing will include contact information and a brief description of the business's mentoring program. Business directories will provide PCHS students with more organized and accessible options for mentorships.

Business Spotlight: WV Division of Rehabilitation Services

The West Virginia Division of Rehabilitation Services (DRS) is a state agency that serves West Virginians with disabilities. The mission of DRS is to enable and empower individuals with disabilities to work and to live independently.

The **vocational rehabilitation** program helps eligible individuals improve their ability to succeed in employment. Basic services may include:

- Work-related counseling and guidance
- Evaluations, information and referral services
- Accessibility and worksite evaluations and accommodations
- Assistive technology
- Vocational training may include college or technical school or on-the-job training

DRS is also a strategic partner in helping to build a diverse, qualified and productive workforce. Their services benefit employers and jobseekers alike. Advantages to employers working with DRS include:

- **On-the-job training:** The on-the-job training program is a partnership between DRS, a client and an employer to prepare the trainee for employment. Employers are reimbursed a percentage of the wage and workers compensation costs incurred during the training period.
- **Job retention:** If an employee is at risk of losing his or her job because of a physical or mental condition, DRS may be able to provide confidential counseling and guidance, assistance in identifying worksite modifications, and other technical assistance to the employer.
- **Accessibility assessments:** DRS can assess the conditions which may create barriers to employing people with disabilities in your workforce or serving your clientele. Employment specialists can make recommendations for improving access for people with disabilities.
